

Clowning Party Entertainment Terms and Conditions Agreement

All deposits are non refundable. Cancellations and rescheduling are allowed outside 48 hours. Cancellations made under 48 hours will result in payment of 50% of total rate. Even if rescheduling is requested. Non-payment under this condition will result in legal action. Cancellation due to a medical emergency, act of terrorism, act of God or death will lead to 50% of rate payment to be voided.

Clowning Party Entertainment reserves the right to terminate this Contract and cancel the event at any time for reasons including but not limited to unforeseen circumstances, safety concerns, or insufficient participation. In the event of termination by Clowning Party Entertainment, Clowning Party Entertainment will refund any payments made by the Participant, including the deposit, within a reasonable time frame.

If the client wishes to change the timeframe of the event after confirmation, we will do our best to accommodate but can not guarantee. If the client wishes to book for less time after booking has been confirmed it will be up to the discretion of the performer if they wish to accept the quote/rate difference. If the performer declines the client can either cancel or reschedule if outside 48 hours. Or remain the booking quote and change the time frame to less time.

Deposits are 20% of the total rate, or minimum \$20 that must be paid to secure the event date and time frame. The exception being if both client and Clowning Party Entertainment have agreed to the deposit being waived while booking due to full collection of payment to be received on the day of service. Performer will not leave until payment has been collected. If a performer is forced to stay past 30 minutes after finished time due to waiting for payment, the client will be charged an extra 30 minutes of service rate, unless a written contract has been made otherwise of an expected payment date. Every two days a payment is late, an additional charge of \$100 will be added to the total amount.

Performers must be able to perform in a safe environment. This includes accommodating to hot and cold weather. The performer has the right to ask to be moved if they feel that they cannot perform services safely. If a medical emergency occurs due to a client forcing a performer to work in an unsafe environment, the client will be held responsible for any medical bills that occur.

If the client agreed to provide a table and two chairs: In the event a table and two chairs are not provided by the client, an additional \$30 set up fee will be added to the total cost if the performer is required to use their own equipment.

The fee covers the necessary arrangements and efforts required to ensure a comfortable seating arrangement for your guests. We strive to provide a seamless and hassle-free experience, and this fee helps us maintain the quality of our service.

If an event has been booked through a platform, all payment transactions will be handled through the platform. Exceptions being if the client wants extra time on the day, those payments will be completed with the performer and the above policy stands.

If for any reason on the day of the event the performer feel unsafe, endangered, or victimized due to sexual harassment, physical or verbal assault or discrimination, they reserve the right to leave the event with no explanation and with no refund given.

Nudity of any kind (child or adult) will NOT be tolerated.

Pictures and videos are welcomed of the performers. By agreeing to these terms and conditions performers are allowed to take pictures or videos and may use them for promotional use. Parents' permission of other children will be asked on site.

If free parking is not available (Street Parking, Parking Lot, Valet etc) Client is responsible for any extra costs for parking for the performers.

The client agrees that either themselves or another appointed adult will always be present. The performer is not to be left alone with children and assume responsibility. If children are left unsupervised and left under the performer's care unexpectedly. The performer has the right to either leave after notifying the client. Or charge an additional \$50/Hour for taking on an additional role of babysitter.

I welcome communication, and if you have any questions or concerns I will be happy to assist you and ease any worries. My hours of communication are 10am to 8pm. I will respond as soon as possible.
